Since 2005 I have been chased out of my good standibg tenancy (.tenant to tenant ) in a repeating cycle of discord rooted t be solved from the HIV community management ( ASOs ) and housing property and building managements several times what I mean by good standing with my

the community peer level to tenant. I was not a trouble maker tenant making chaos for the building residence.

No, that was not the source of conflict that arose.

What festers up is a methodologies of hate and harassment conducted by a community against one member attempting to improve and build resources.

Ever since I first encountered this hate paradigm characters involved in management of aryan White funding in a community targeted against me.

Cascading downward has always led to a failure of my tenancy which is the target source they attacked me. The point of most vulnerable that eventually collapsed my tenancy to repeating cycles of homelessness since 2005.

I can prove that the fault does not lie on my efforts to build up community relationships and affairs. Where I stand today?

I am spending \$800.a months for a room and board shared house with about 10 other residents beds there.

I am stuck in San Bernardino County being blacked balled from social services such as Foothill Aids Project here in San Bernardino. ( Note their Google, Glassdoor, and Indeed Reviews ).

The reviews call for a complete overhaul of management. I have been lifetime banned from services.

I have declared the conflict and continuous environment I am living here in San Bernardino since my return to my hometown in July 2016 as nightmarish.

I will never be free from what is a crime being committed against me.

That crime is defined at [mylawquestion.com](http://mylawquestion.com)

I am a targeted individual of gangstalking.

This disconnection from social services as well as doctor provider care in HIV has basically placed me into a catastrophic failure of HIV Treatment.

Last January, I made a despatate forced dislocation to travel by Greyhound Bus and crash onto the streets of Los Angeles to attempt to get care when my CD4/CD8 ratio was at 0.38. 38 points down from normalized ratio blood work values. Gang stalking refers to harassment and intimidation tactics used by a group of individuals against another person or toward a smaller group of people. People may initiate this type of civil offense because they are intolerant of another person for numerous reasons, which might include differing beliefs or lifestyles, jealousy, or racial prejudice. Stalkers generally design the covert methods used for psychological harassment to exact revenge, coerce silence, or cast out persons having opposing views. While gang stalking is considered a misdemeanor in some states, the offense carries felony penalties in others.

The number of people involved in the gang varies. Individuals might receive gang intimidation from a handful of people in a work environment, or they may be targeted by an entire community. Victims relaying claims of gang stalking perceive the attackers as well-organized groups of people, who not only communicate with one another in a certain location but also pursue the target in other areas by means of extensive contacts. Leaders generally enlist the aid of other individuals in the gang by various methods, which typically include providing false information about the victim, manipulating potential members, or employing those with similar criminal backgrounds.

Jealousy may be a cause of gang stalking.

Victims may be from any gender or socioeconomic background. These persons may outperform other co-workers, or have a set of standards that separates them from other people in an environment. Gang stalking frequently uses practices meant to destroy the victim's qualities. These acts might include blaming the target for a gang member's mistakes or taking credit for what the victim accomplished. In an effort to discredit a person or to add to the weaponry for the attack gang stalkers may perpetuate the notion that the target is mentally impaired or dangerous in some manner, forcing the person to undergo evaluation.

The list of physical tactics used against victims generally includes stalking behavior and unwanted attention. The majority of persons under attack report that stalkers frequently mirror the victim's behavior. Gang stalking might include mirroring physical gestures or verbal comments. Many victims relay that gang members often enter or leave properties and other locations at the same time as the target. Victims also frequently report that stalkers often repeat private conversations occurring in a home environment or over the phone.

Gang stalking targets might also experience hang-up calls or calls from wrong phone numbers throughout the day. Attackers may enter homes illegally or employ the assistance of the target's friends or family. In an attempt to confuse the victim or to cause them to doubt their own logic and reasoning, stalkers might rearrange or steal personal items in the work place or home. The criminal offenses of stalkers may become more aggressive or violent against the target, family members or pets.

Is Gang Stalking Real?

"Gang stalking" does not necessarily mean you are being stalked by a street gang (they usually have bigger fish to fry, unless you have crossed them in some way). The term simply refers to a form of bullying by groups against an individual or smaller groups. Sadly, this behavior is common among school children and teens, especially when the victims are different or stand out in some way. However, it can also happen with adults in the workplace, on college campuses and other places.

There are all kinds of motivations for gang stalking. Intolerance, prejudice, homophobia and racism are certainly among them, but often, the reasons are more personal. Envy or jealousy, fear of "the other," intimidation and exclusion or ostracization are also common motivators. So are vindictiveness and revenge. Sometimes, there is no apparent reason. This kind of behavior, known to behaviorists and biologists and as "mobbing," appears to happen among most mammal species.

Gang stalking can take multiple forms. It may be perpetrated by a loose association of people who just happen to have it in for the victim(s), or it can be a highly orchestrated campaign by a larger group, or even an entire community. Gang stalking usually happens in the brick-and-mortar world, but thanks to social media and the Internet, it can happen online as well. It needn't be threats of physical violence; under the cloak of Web-based anonymity, stalkers can continue to harass and post libelous stories about their victims. Victims may also receive relentless, harassing telephone calls.

Gang stalking is considered a crime, though it may be a misdemeanor or a felony, depending on the jurisdiction and what form the stalking/bullying takes. If factors such as racism or antisemitism come into the equation, it may be considered a hate crime, which is a Federal offense.

Although gang stalking appears to be on the rise, it only seems that way. The good news is that more victims are speaking out and reporting such behavior when it affects them.

How To Stop Gang Stalking

One tactic that gang stalkers use is referred to as "gaslighting." The phrase comes from an old movie in which a murderer marries his victim's niece, then uses a series of lies, half-truths and other kinds of manipulation in order to convince her that she is going insane. The victim may find themselves the target of blame, or the gang might attempt to publicly

discredit them or insinuate that they suffer from some mental disorder or delusion. Understand that it is not your imagination, that what you are being put through is very real. Have confidence (which can be challenging under the circumstances) and learn to trust yourself.

After that, the most important thing you can do is to document everything. Fortunately, modern technology has given us a plethora of tools for recording all kinds of events. It has often been said that sunlight is the best disinfectant; shine as much light on the situation as possible. If you can, enlist the aid of trusted friends and family to help in keeping records of what is going on.

Although gang stalkers are not always violent, it's a good idea to protect yourself. Wear a helmet if you are out cycling, and carry pepper spray if it is legal in your jurisdiction, or some kind of an alarm. When out and about, whether in public, campus or the office, stay in heavily-trafficked areas where everyone can see what is happening.

#### What to Do About Gang Stalking

If you find that you are being harassed because of your race, ethnicity, religious beliefs or sexuality, you should know that you have allies and support. For example, if you are African-American, you can turn to the NAACP, or even the ACLU for help and resources. Similar organizations for frequently-targeted groups include:

Council on American-Islamic Relations  
Las Americas Immigrant Advocacy Center  
Black Lives Matter  
Anti-Defamation League

Those who find themselves stalked, harassed and bullied for other reasons also have options. Most companies and academic institutions have personnel whose job it is to address such problems. Otherwise, the adage, "If you see something, say something" still applies. Even if you are not the victim, if you know of someone who is a victim of gang stalking, report it to law enforcement. If you are being harassed over the phone, contact your carrier, as they may be able to take some action (although these days of caller ID, phone harassment is much easier to avoid).

#### What to Know About the CD4:CD8 Ratio Test

CD4 and CD8 are two types of white blood cells in your blood. CD4 cells are also called T-helper cells, T-suppressor cells, and cytotoxic T-cells. They help the body fight infections. CD8 cells are also called cytotoxic T-lymphocytes. They help fight cancer and germs that live inside your cells (intracellular pathogens). The human immunodeficiency virus (HIV) chiefly targets CD4 cells. A reduced number of these cells and a change in the CD4:CD8 ratio are signs of HIV infection. The CD4:CD8 ratio helps your physician judge disease activity and your response to treatment.

#### CD4 Cell Count

The CD4 cell count is a good measure of the activity of the HIV infection and the success of the treatment. Normal CD4 numbers in the blood range between 500 to 1200 per cubic millimeter. The normal range for CD8 is 150 to 1000 per cubic millimeter. A CD4:CD8 ratio of more than 1.0 is considered normal. A CD4 count below 200 per cubic millimeters shows that you have acquired immunodeficiency syndrome (AIDS). Low CD4 counts are also seen in bone marrow suppression because of chemotherapy, long-standing infections, and some types of anemia.

Once you start ART (antiretroviral therapy, a combination of antiviral medicines), your CD4 cell count increases gradually. Your physician will get your CD4 count tested every 3 to 6 months. The return of the CD4 count to normal levels (500 per cubic millimeter) is a sign that the HIV infection is under control.

#### CD4:CD8 Ratio

Traditionally, CD4 counts and viral loads were used to judge the body's response to HIV treatment. But you may be experiencing a weakening of your immune system despite having a normal CD4 count. The CD4:CD8 ratio is more useful in judging the immune system's function. People with HIV and a low CD4:CD8 ratio have increased frailty and mortality.

The total CD4 number, their proportion (CD4 percentage), and their ratio to CD8 cells (CD4:CD8 ratio) are tests used to guide HIV treatment. A CD4:CD8 ratio of more than 1.0 is considered normal. A low ratio (more CD8 cells than CD4) is often seen in HIV infections.

The CD4:CD8 ratio test judges the strength of your immune system. It also tells your physician if you are at risk for opportunistic infections like pneumocystis pneumonia. Your physician may want to protect you by prescribing some medicines.

A low CD4:CD8 ratio during treatment predicts that the virus hasn't been completely removed from your blood. If treatment begins early in the course of an HIV infection, your CD4:CD8 ratio is likely to become normal in about 6 years. Late and irregular treatments are associated with this test remaining abnormal.

The currently used antiretroviral drugs are very effective. Viral loads become undetectable in the blood, and the CD4 count returns to normal with some years of treatment. But several complications of AIDS still happen. The CD4:CD8 ratio is more accurate at predicting the risk of AIDS-associated cancers such as Kaposi's sarcoma and non-Hodgkins lymphoma.

#### Low CD4:CD8 Ratio

This test is most often done to assess HIV infection status, but it also helps in the diagnosis and monitoring of other diseases:

Infectious mononucleosis

Chronic lymphocytic leukemia

Hodgkin disease (lymphoma)

Aplastic anemia

Multiple sclerosis

Myasthenia gravis

DiGeorge syndrome

Organ transplantation

High CD4/CD8 Ratio

The CD4:CD8 ratio can be high in:

Major bacterial infection

Viral infection

Some types of blood cancer

Testing for HIV

HIV is the most frequent reason for abnormal CD4:CD8 ratios. But this test should not be used to diagnose an HIV infection. Your physician will ask for antigen, antibody, or nucleic acid tests to diagnose an HIV infection.

Once your physician has diagnosed HIV, they will start treatment. The CD4:CD8 ratio test and the CD4 cell count are helpful in assessing the progress of the infection. Your physician uses these tests to know if your infection is under control and whether you are at risk of complications.

Another way to assess the progress of the HIV infection is to test the viral load. This measures the amount of HIV in your blood. A high viral load means that your immune system is not fighting the virus well. Your physician will test your viral load every 4 to 6 months, and will also test it if they change your medicines.

#### High CD8 Counts

Your doctor monitors CD8 counts frequently while you are on treatment for HIV. If your CD8 count is high, it means your viral load is low. Your CD4 count is likely to return to normal levels. CD8 cells are important in the body's defense against HIV, and high CD8 count means that your body is effectively controlling the infection.

If your CD8 counts have been low or normal for some time and then become high, your physician is warned that treatment failure is about to happen. The CD8 cells increase in response to increasing viral load. Treatment failures happen in 20% to 40% of people on ART. Your doctor will ask if you're regular about taking your medicines, and consider other causes of treatment failure.

HIV infection is a deadly disease a few decades ago. People with untreated AIDS usually die within three years. With treatment and proper monitoring, people with HIV can live long and productive lives. CD4 counts, viral loads, and the CD4:CD8 ratio tests help your physician judge your disease control and fine-tune your treatment. Getting these tests done regularly will help you keep the infection under control.

I was not a trouble maker tenant making chaos for the building residence.

No, that was not the source of conflict that arose.

What festers up is a methodologies of hate and harassment conducted by a community against one member attempting to improve and build resources.

Ever since I first ecountered this hate paradigm characters involved in management of aryan White funding in a community targeted against me.

Cascading downward has always led to a failure of my twnacy which is the target source they attacked me. The point of most vulnerable that eventually collapsed my tenancy to repeating cycles of homelessness since 2005.

The reviews call for a complete overhaul of management. I have been lifetime banned from services.

I have declared the conflict and continuous environment I am living here in San Bernardino since my return to my hometown in July 2016 as nightmarish.

I will never be free from what is a crime being committed against me.

I am a targeted individual of gangstalking.

This disconnection from social services as well as doctor provider care in HIV has basically placed me into a catastrophic failure of HIV Treatment.

Last January, I made a despatate forced dislocation to travel by Greyhound Bus and crash onto the streets of Los Angeles to attempt to get care when my CD4/CD8 ratio was at 0.38. 38 points down from normalized ratio blood work values. What Is Gang Stalking?

Gang stalking refers to harassment and intimidation tactics used by a group of individuals against another person or toward a smaller group of people. People may initiate this type of civil offense because they are intolerant of another person for numerous reasons, which might include differing beliefs or lifestyles, jealousy, or racial prejudice. Stalkers generally design the covert methods used for psychological harassment to exact revenge, coerce silence, or cast out persons having opposing views. While gang stalking is considered a misdemeanor in some states, the offense carries felony penalties in others.

The number of people involved in the gang varies. Individuals might receive gang intimidation from a handful of people in a work environment, or they may be targeted by an entire community. Victims relaying claims of gang stalking perceive the attackers as well-organized groups of people, who not only communicate with one another in a certain location but also pursue the target in other areas by means of extensive contacts. Leaders generally enlist the aid of other individuals in the gang by various methods, which typically include providing false information about the victim, manipulating potential members, or employing those with similar criminal backgrounds.

Jealousy may be a cause of gang stalking.

Victims may be from any gender or socioeconomic background. These persons may outperform other co-workers, or have a set of standards that separates them from other people in an environment. Gang stalking frequently uses practices meant to destroy the victim's qualities. These acts might include blaming the target for a gang member's mistakes or taking credit for what the victim accomplished. In an effort to discredit a person or to add to the weaponry for the attack gang stalkers may perpetuate the notion that the target is mentally impaired or dangerous in some manner, forcing the person to undergo evaluation.

The majority of persons under attack report that stalkers frequently mirror the victim's behavior. Gang stalking might include mirroring physical gestures or verbal comments. Many victims relay that gang members often enter or leave properties and other locations at the same time as the target. Victims also frequently report that stalkers often repeat private conversations occurring in a home environment or over the phone.

Gang stalking targets might also experience hang-up calls or calls from wrong phone numbers throughout the day. Attackers may enter homes illegally or employ the assistance of the target's friends or family. In an attempt to confuse the victim or to cause them to doubt their own logic and reasoning, stalkers might rearrange or steal personal items in the work place or home. The criminal offenses of stalkers may become more aggressive or violent against the target, family members or pets.

Is Gang Stalking Real?

"Gang stalking" does not necessarily mean you are being stalked by a street gang (they usually have bigger fish to fry, unless you have crossed them in some way). The term simply refers to a form of bullying by groups against an individual or smaller groups. Sadly, this behavior is common among school children and teens, especially when the victims are different or stand out in some way. However, it can also happen with adults in the workplace, on college campuses and other places.

There are all kinds of motivations for gang stalking. Intolerance, prejudice, homophobia and racism are certainly among them, but often, the reasons are more personal. Envy or jealousy, fear of "the other," intimidation and exclusion or ostracization are also common motivators. So are vindictiveness and revenge. Sometimes, there is no apparent reason. This kind of behavior, known to behaviorists and biologists and as "mobbing," appears to happen among most mammal species.

Gang stalking can take multiple forms. It may be perpetrated by a loose association of people who just happen to have it in for the victim(s), or it can be a highly orchestrated campaign by a larger group, or even an entire community. Gang stalking usually happens in the brick-and-mortar world, but thanks to social media and the Internet, it can happen online as well. It needn't be threats of physical violence; under the cloak of Web-based anonymity, stalkers can continue to harass and post libelous stories about their victims. Victims may also receive relentless, harassing telephone calls.

Gang stalking is considered a crime, though it may be a misdemeanor or a felony, depending on the jurisdiction and what form the stalking/bullying takes. If factors such as racism or antisemitism come into the equation, it may be considered a hate crime, which is a Federal offense.

Although gang stalking appears to be on the rise, it only seems that way. The good news is that more victims are speaking out and reporting such behavior when it affects them.

How To Stop Gang Stalking

One tactic that gang stalkers use is referred to as "gaslighting." The phrase comes from an old movie in which a murderer marries his victim's niece, then uses a series of lies, half-truths and other kinds of manipulation in order to convince her that she is going insane. The victim may find themselves the target of blame, or the gang might attempt to publicly discredit them or insinuate that they suffer from some mental disorder or delusion. Understand that it is not your imagination, that what you are being put through is very real. Have confidence (which can be challenging under the circumstances) and learn to trust yourself.

After that, the most important thing you can do is to document everything. Fortunately, modern technology has given us a plethora of tools for recording all kinds of events. It has often been said that sunlight is the best disinfectant; shine as much light on the situation as possible. If you can, enlist the aid of trusted friends and family to help in keeping records of what is going on.

Although gang stalkers are not always violent, it's a good idea to protect yourself. Wear a helmet if you are out cycling, and carry pepper spray if it is legal in your jurisdiction, or some kind of an alarm. When out and about, whether in public, campus or the office, stay in heavily-trafficked areas where everyone can see what is happening.

What to Do About Gang Stalking

If you find that you are being harassed because of your race, ethnicity, religious beliefs or sexuality, you should know that you have allies and support. For example, if you are African-American, you can turn to the NAACP, or even the ACLU for help and resources. Similar organizations for frequently-targeted groups include:

Council on American-Islamic Relations  
Las Americas Immigrant Advocacy Center  
Black Lives Matter  
Anti-Defamation League

Those who find themselves stalked, harassed and bullied for other reasons also have options. Most companies and academic institutions have personnel whose job it is to address such problems. Otherwise, the adage, "If you see something, say something" still applies. Even if you are not the victim, if you know of someone who is a victim of gang stalking, report it to law enforcement. If you are being harassed over the phone, contact your carrier, as they may be able to take some action (although these days of caller ID, phone harassment is much easier to avoid).

What to Know About the CD4:CD8 Ratio Test

CD4 and CD8 are two types of white blood cells in your blood. CD4 cells are also called T-helper cells, T-suppressor cells, and cytotoxic T-cells. They help the body fight infections. CD8 cells are also called cytotoxic T-lymphocytes. They help fight cancer and germs that live inside your cells (intracellular pathogens). The human immunodeficiency virus (HIV) chiefly targets CD4 cells. A reduced number of these cells and a change in the CD4:CD8 ratio are signs of HIV infection. The CD4:CD8 ratio helps your physician judge disease activity and your response to treatment.

#### CD4 Cell Count

The CD4 cell count is a good measure of the activity of the HIV infection and the success of the treatment. Normal CD4 numbers in the blood range between 500 to 1200 per cubic millimeter. The normal range for CD8 is 150 to 1000 per cubic millimeter. A CD4:CD8 ratio of more than 1.0 is considered normal. A CD4 count below 200 per cubic millimeters shows that you have acquired immunodeficiency syndrome (AIDS). Low CD4 counts are also seen in bone marrow suppression because of chemotherapy, long-standing infections, and some types of anemia.

Once you start ART (antiretroviral therapy, a combination of antiviral medicines), your CD4 cell count increases gradually. Your physician will get your CD4 count tested every 3 to 6 months. The return of the CD4 count to normal levels (500 per cubic millimeter) is a sign that the HIV infection is under control.

#### CD4:CD8 Ratio

Traditionally, CD4 counts and viral loads were used to judge the body's response to HIV treatment. But you may be experiencing a weakening of your immune system despite having a normal CD4 count. The CD4:CD8 ratio is more useful in judging the immune system's function. People with HIV and a low CD4:CD8 ratio have increased frailty and mortality.



The total CD4 number, their proportion (CD4 percentage), and their ratio to CD8 cells (CD4:CD8 ratio) are tests used to guide HIV treatment. A CD4:CD8 ratio of more than 1.0 is considered normal. A low ratio (more CD8 cells than CD4) is often seen in HIV infections.

The CD4:CD8 ratio test judges the strength of your immune system. It also tells your physician if you are at risk for opportunistic infections like pneumocystis pneumonia. Your physician may want to protect you by prescribing some medicines.

A low CD4:CD8 ratio during treatment predicts that the virus hasn't been completely removed from your blood. If treatment begins early in the course of an HIV infection, your CD4:CD8 ratio is likely to become normal in about 6 years. Late and irregular treatments are associated with this test remaining abnormal.

The currently used antiretroviral drugs are very effective. Viral loads become undetectable in the blood, and the CD4 count returns to normal with some years of treatment. But several complications of AIDS still happen. The CD4:CD8 ratio is more accurate at predicting the risk of AIDS-associated cancers such as Kaposi's sarcoma and non-Hodgkins lymphoma.

#### Low CD4:CD8 Ratio

This test is most often done to assess HIV infection status, but it also helps in the diagnosis and monitoring of other diseases:

Infectious mononucleosis  
Chronic lymphocytic leukemia  
Hodgkin disease (lymphoma)  
Aplastic anemia  
Multiple sclerosis  
Myasthenia gravis  
DiGeorge syndrome  
Organ transplantation

#### High CD4/CD8 Ratio

The CD4:CD8 ratio can be high in:

Major bacterial infection  
Viral infection  
Some types of blood cancer  
Testing for HIV

HIV is the most frequent reason for abnormal CD4:CD8 ratios. But this test should not be used to diagnose an HIV infection. Your physician will ask for antigen, antibody, or nucleic acid tests to diagnose an HIV infection.

Once your physician has diagnosed HIV, they will start treatment. The CD4:CD8 ratio test and the CD4 cell count are helpful in assessing the progress of the infection. Your physician uses these tests to know if your infection is under control and whether you are at risk of complications.

Another way to assess the progress of the HIV infection is to test the viral load. This measures the amount of HIV in your blood. A high viral load means that your immune system is not fighting the virus well. Your physician will test your viral load every 4 to 6 months, and will also test it if they change your medicines.

#### High CD8 Counts

Your doctor monitors CD8 counts frequently while you are on treatment for HIV. If your CD8 count is high, it means your viral load is low. Your CD4 count is likely to return to normal levels. CD8 cells are important in the body's defense against HIV, and high CD8 count means that your body is effectively controlling the infection.

If your CD8 counts have been low or normal for some time and then become high, your physician is warned that treatment failure is about to happen. The CD8 cells increase in response to increasing viral load. Treatment failures happen in 20% to 40% of people on ART. Your doctor will ask if you're regular about taking your medicines, and consider other causes of treatment failure.

HIV infection was a deadly disease a few decades ago. People with untreated AIDS usually die within three years. With treatment and proper monitoring, people with HIV can live long and productive lives. CD4 counts, viral loads, and the CD4:CD8 ratio tests help your physician judge your disease control and fine-tune your treatment. Getting these tests done regularly will help you keep the infection under control.
